Credit searches

To make sure you get the best possible price offer from our insurers, now or at any renewal or at any time and to protect our customers from fraud and to verify your identity, we may use publicly available data which they obtain from a variety of sources, including a credit reference agency and other external organisations. This search will appear on your credit report whether or not your applications proceed.

As well as these searches we may use a credit check to ascertain the most appropriate payment options for you. This credit check will

also appear on your credit report whether or not your applications proceed.

Your rights of cancellation

If for any reason the policy does not meet your requirements, you have the right to cancel within 14 days of receiving the policy documentation. To cancel your policy you need to request this in writing.

If you cancel within the first 14 days you will be entitled to a refund subject to a pro rata deduction for the period of time which you have been covered. A £20 charge will be applied to cover our administration costs. Please note the insurer may also charge a nominal sum to cover the cost of setting up the policy, this is outlined in the policy booklet.

No cancellation rights exist where a claim has been made on the policy and the full year's premium will be charged.

Tax and costs

Any taxes or costs that arise outside of our control may need to be passed onto you. All prices quoted include insurance premium tax at 5%.
